Dear St Finbar's Community

It is hard to believe that the year is almost at its end! Where has the time gone? As a school we are preparing for the new year and reflecting on our many achievements of 2015. It is fitting that the Church is also liturgically situated in the very same state of being. The liturgical name given to this season is Advent. This Sunday we heard the word from Luke's Gospel:

Luke 21:25-28

25 "There will be signs in the sun, moon and stars. On the earth, nations will be in anguish and perplexity at the roaring and tossing of the sea. **26** People will faint from terror, apprehensive of what is coming on the world, for the heavenly bodies will be shaken. **27** At that time they will see the Son of Man coming in a cloud with power and great glory. **28** When these things begin to take place, stand up and lift up your heads, because your redemption is drawing near."

Dianne Bergant CSS provides us with great wonderings in the following reflection: The readings of the First Sunday of Advent set the stages for our reflections on the entire season. They contain a number of promises, all pointing to peace and fulfilment. Each reading depicts a dimension of suffering that was often brought on by the people themselves. The promises are assurances that the end of their suffering was in sight. The promises reveal a loving and provident, a merciful and forgiving God. These are promises full of hope.

The coming of the Lord is clearly a time of expectation, not of fear and trembling. Although the earlier tradition about the Day of the Lord included punishment of the wicked, the focus here is on redemption. The time of expectation may be preceded by apocalyptic signs in the heavens and dismay on earth, but this cosmic shift will bring fulfilment, not destruction. The love and providence, the mercy and forgiveness of God will be made manifest.

What is expected of those who receive the promise? An Advent way of life exhorts us to 'wait in joyful hope for the coming of our Saviour Jesus Christ'. This way of life is both simple and profound. It does not necessarily require unusual behaviour on our part, but it calls us to live the usual unusually well. It affects the everyday events of life; it directs the way we interact with people; it informs the attitudes that colour our judgments and motivations. It is as ordinary as the birth of a child; it is as extraordinary as the revelation of God.

<u>St Finbar's Junior Paramedics</u> By the Media team

On the 18th of November, St Finbar's had a special guest come to talk to stage 2 and stage 3 about the DRSAB system. Mrs Cheryl Lynch visited the school to deliver St John's Ambulance "*First Aid in Schools*" Program. Mrs Lynch taught them how to treat an unconscious person and how to put a bandage on someone that's injured.

We interviewed some students that attended the event and asked them what they learnt on the day. Year 6 student, Sofia told us what "DRSAB" stands for: check for Danger, see if they are Responding, Send for help if they are unconscious, make sure their Airway is free and if they are Breathing."

The students also learnt about calling 000. Year 5 student, Daniel said you need to tell them what street you're on and what phone number you are calling from.

We asked Scarlett from year 4 why she thought they were being taught about bandages and calling Triple 0. Scarlett responded, "So if there is an emergency and there are no parents around you will know what to do."

The kids really enjoyed the day. Hunter from year 3 said his favourite part was putting his partner in the recovery position, even though it was a bit awkward.

Cheryl Lynch was a great first aid trainer. The kids picked up a lot of information for the future. Overall the day was great, highly useful and was enjoyed by everyone.

My Airport Concerns

I have long-held concerns about the impact on the Blue Mountains community resulting from a new airport at Badgerys Creek.


It's critically important that the NSW Government fights for adequate protections.

The key issues a great number of Blue Mountains residents have raised with me include:

- The concentration of arriving flight paths over Springwood, Winmalee, Blaxland and Glenbrook
- The overflight of aircraft above World Heritage listed Blue Mountains National Parks
- The risk to Sydney's drinking water catchment from overflying aircraft
- The lack of public transport links to Penrith, Parramatta and the Sydney CBD
- The inequity of the Western Sydney airport operating without an overnight curfew.

I encourage anyone who has concerns about the airport to contribute to the Environmental Impact Statement consultation process by completing the EIS submission on the back page of this Update.




An EIS is a statutory requirement for any major infrastructure project. It must contain details of all the impacts of the project on the local environment during and after construction.

The EIS for the Western Sydney Airport project at Badgerys Creek, will investigate and assess aircraft noise, flight paths, air quality, transport links and long term airport operation plans.

The EIS process is the only chance for Blue Mountains residents to tell the Baird and Turnbull Governments what they think of the project.

Find out more, get your questions answered and Have Your Say on the draft EIS & Airport Plan.

For such a significant proposal affecting the liveability of the Lower Mountains & Western Sydney for the next Century....

you may like to consider asking WHY:

- It he draft EIS doesn't offer certainty on key issues such as aircraft noise, flight paths, traffic, transport, and the environment?
- are the flight paths concentrated over the lower mountains residential area?
- aircraft noise isn't evenly spread across Western Sydney?
- was the draft EIS so rushed, prepared in just 8 months, for such a complex project?
- are there no limits on noise impacts of airport operations?
- are residential impacts not discussed or mitigation measures not quantified?
- Ithese flight paths were chosen and other flight path options were not considered or modelled in the draft EIS?
- are impacts on the World Heritage Area not considered in greater detail?
- doesn't a curfew apply to Western Sydney Airport?
- what homes, schools, child care centres and nursing homes are eligible for roof sound insulation and double glazing windows as compensation for the noise impacts?
- the raw data, on which conclusions are based, was not made available to the independent review team commissioned by 11 Western Sydney councils?
- the draft EIS did not always adhere to EIS Guidelines, did not conform to best practice in many areas, lacked detailed modelling and contained information gaps for many key assumptions?
- the Western Sydney Airport is considered in isolation, not real world conditions?
- the draft EIS provides no assessment of the material impacts of aircraft noise on communities and families and as a result can't offer specific mitigation measures or noise limitations that must be adhered to – precisely what an EIS should do?
- no detailed modelling of traffic and transport was conducted for this project as is common practice for other projects such as the WestConnex, North West Rail Link and South West Rail Link?
- claims being made by the Australian Government about economic generation and job creation have not been explicitly tested in the draft EIS?
- the EIS' conclusion that there would be low noise impact on the Greater Blue Mountains World Heritage Area is not adequately justified and does not consider the value of the natural soundscape to the community, and the region's significant tourism economy?
- social determinants of health have not been considered. For example equitable access to employment and impacts on the amenity of local communities because of traffic generation associated with the airport and the surrounding enterprise precinct?

the EIS assumes a rail service supporting the airport at some point in time but does not indicate when, nor does it consider the cumulative adverse effects (access and amenity) to local communities without the rail line being built?
