School Based Fees 2017

Resource Fee (Per Student):

\$128.00 covers copyright fees, paper, books, printing costs, art materials, texts, book hire and exercise books.

<u>Information Communication Technology Levy (Per Student)</u>:

\$108.00 supports the ongoing purchase and updating of our technology hardware.

School Activities Fee (Per Student):

\$186.00 (Kindergarten to Year 4)

\$195.00 (Years 5 & 6)

This fee covers activities such as performances, Life Education, visiting groups and special activity days. The fee also covers the licensing costs for the online programs Reading Eggs and Mathletics, which can be accessed at school and at home, and the cost of providing the *Dance Fever* programs for Gymnastics in Term 1 and Dance in Term 4. This annual fee was introduced to alleviate the need and management of frequent, smaller amounts of money from parents and by staff.

This year we have incorporated our yearly excursion as per direction from CEDP to enable our families to have the opportunity to pay this through our flexible payment plan. Please note this year there will be no overnight excursion for Years 5 & 6. End of year activities for Year 6 (ie: Formal/Fun day are not included in this fee)

Family Contribution fee (Per Family):

\$150.00 - This annual fee was introduced in consensus with the whole school community, is a fair, easy and popular way to raise funds to improve our facilities for our students. It also eliminates the need for fundraising ventures such as school fetes, dance-a-thons and chocolate drives which require many people to organise and carry out the work. Contact us to learn more about our Family Contribution fee funded goals for this year.

Initiatives that primarily provide a service to the school and its students, and are well established and supported within our school community, such as Special Food Days, Mothers and Fathers day stalls, Book Fairs and Book Clubs, continue to be offered. The proceeds of these activities go directly towards the cost of operating each initiative.

Term 3 - Due Monday 21 August 2017

Dear parents and carers

Please find below the 2017 Diocesan school fees schedule which includes a modest 3.0% increase on the fees from 2016. Every effort has been made to keep the fee increase to a minimum and I am pleased to report that the increase is *less than* the 3.3% education CPI increase for the same period.

School-based fees will also be limited to a 3.0% increase to ensure we have consistency across our Diocese. School-based fees cover the costs of important things such as technology and school administration.

I appreciate that from time to time, some families might experience financial challenges. With this in mind, I take this opportunity to remind you that confidential fee support is available through

- discounts for families with multiple siblings in our schools
- flexible payment plans
- hardship concession policies for families in need
- the Bishop Manning Scholarship Fund
- the Byawalla Co-contribution Scheme for Aboriginal and Torres Strait Islander families.

Diocesan Building Levy - 2017

The Diocesan Building Levy enables us, through our capital works program, to meet the demand for new schools and new classes in high growth areas, and to continue to maintain all schools to a high standard.

All families with one or more children in a Parramatta Diocesan school or at St Dominic's College Kingswood are required to pay the annual Diocese of Parramatta Diocesan Building Levy. This levy has replaced the various building levies that parents previously paid to school building funds (managed by either parishes or schools). The levy for 2017 is \$756 per family, payable in three equal instalments of \$252 payable in Terms 1, 2 and 3.

Annual Diocesan Education Fee Temporary Residents - 2017

The Diocesan Education Fee Temporary Residents for 2017 **is \$1,869** per student, payable in three equal **instalments of \$623** in Terms 1, 2 and 3. The fee applies to new students on the following visa numbers: 173, 401, 402, 411, 415, 416, 417, 418, 419, 420, 421, 422, 423, 426, 427, 428, 442, 456, 457, 459, 462, 476, 485, 497, 580, 600, 601, 651, 675, 676, 679, 685, 884, 944, 956, 976 and 977 including where any of these are the preceding visas for families on bridging visas 010 to 090.

Families charged this fee in 2013 will continue to be charged on a *per family* basis to the eldest student whilst the family has continuous current students.

Thank you for your continuing support of Catholic education. Please be assured that we will continue to provide exciting learning experiences for them within our Catholic faith environment.
